THE MIGORI COUNTY SUPPLEMENTARY APPROPRIATION BILL, 2019

A Bill for

AN ACT of Migori County Assembly to authorize the issue of a sum of money out of the County Revenue Fund and its application towards the service of the year ending on the 30th June, 2019 and to appropriate that sum as voted on account by the County Assembly for certain public services and purposes

ENACTED by the County Assembly of Migori County, as follows—**Short title**

1. This Act may be cited as the Migori County supplementary Appropriation Act, 2019.

Issue of KSh. 8,801,117,673 out of the Migori County Revenue Fund Account for service of the year ending 30th June, 2019 and appropriation of the money granted.

- 2. (1) The County Treasury may issue out of the County Revenue Fund and apply towards the supply granted for the service of the year ending on the 30th June, 2019 the sum of Kenya Shillings Eight billion, eight hundred and one million, one hundred and seventeen thousand, six hundred seventy three, and that sum shall be deemed to have been appropriated as from 1st July, 2018, for the services and purposes specified in the Schedule.
- 3. In addition to the sum granted by section 2, there may be applied, for the several services and purposes specified in the Schedule, the sums specified out of any money directed to be applied as Revenue under section 132(1) of The Public Finance Management Act, 2012.
